1. General

By using this Application and adding your AVATAR and name to any leader-board or scoring chart, you agree for us to use this information across other portals owned and operated by Prime8 International Limited.

2. Our privacy commitment

3. Who we are

We will not share your personal information with any other 3rd parties, unless:

1. we have prior written permission.
2. it is specifically stated as a requirement of joining a competition.

We will hold your personal information for a period to satisfy UK law.

It is not a pre-requisite of the use of the Application to provide personal information.

7. Disqualification

We may at our sole discretion disqualify and/or remove any Player that we feel is abusing, found to be tampering or interfering with the Application and/or any of its constituent elements, in any way.

8. Security of information

We will use all reasonable efforts to secure your personal data, in using the Application, however, you acknowledge that the use of the internet is not entirely secure and for this reason we cannot guarantee the security or integrity of any personal data that are transferred from you or to you via the internet.
